## 2017 Jeep Cherokee Giveaway

This incentive promotion conducted by the United Way of Southwestern Indiana (UWSWI) begins at 8 am Central Standard Time on August 1, 2017, and ends at 5 p.m. Central Standard Time on December 31, 2017. Participants must be legal residents of Vanderburgh, Warrick or Spencer Counties in Indiana; or be employed by a company /organization located in Vanderburgh, Warrick or Spencer Counties in Indiana. Participants must be at least 18 years of age, and possess a valid driver's license.

The winner will receive a 2017 Jeep Cherokee (approximate MSRP value \$23,695) donated to the United Way of Southwestern Indiana (UWSWI) by Audubon Chrysler Center, Bennett Motors and Dream Car Museum. No campaign contributions were used to purchase the automobile. Odds of winning depend on number of eligible entries received.

Any UWSWI individual donor that timely increases his/her gift by at least \$50 over his/her 2016 Campaign Gift will be automatically entered for one chance to win. Any UWSWI individual donor that timely increases his/her gift by at least \$100 over his/her 2016 Campaign Gift will be automatically entered for two chances to win. Any new donor that pledges a Campaign Gift of \$50 or more will be automatically entered for one chance to win. Any new donor that pledges a Campaign Gift of \$100 or more, will be automatically entered for two chances to win. Entry without donation can also be made by completing an Official Entry Form, which can be picked up at the United Way Office located at 501 NW 4<sup>th</sup> Street, Evansville, IN. Only one non-donation entry, automatic or otherwise, per person.

Pledges or Entry Forms must be returned to the UWSWI by 5 p.m. Central Standard Time on December 31, 2017. UWSWI will not be responsible for companies that fail to submit their employees' pledge forms or employees' names by this date. UWSWI will not be responsible for lost or misdirected mail. All late, lost or incomplete entries are invalid entries, regardless of cause.

Three finalists will be randomly drawn by January 16, 2018. The final drawing of the winner of the 2017 Jeep Cherokee will take place at the Dream Car Museum in February 2018. Finalists must be present to win. Finalists will be notified by telephone and/or email. They will have 3 days to respond to the notification. If any finalist fails to respond within the given time period, an alternate finalist will be chosen. Employees, officers and directors of UWSWI, Audubon Chrysler Center, Bennett Motors, Dream Car Museum, and members of their immediate families are not eligible to participate.

**Ensuring the Integrity of the 2017 Jeep Cherokee Drawing Entries:**

Those individuals that qualify for the 2017 Jeep Cherokee are automatically and systematically (not manually) entered into the drawing as their pledges are processed. Participating workplace campaigns who provide individual donor information to the United Way can be assured that their donations will be eligible for the drawing. Companies, who do not typically provide individual pledge information, may submit a list of those employees who have qualified. Those names are added to the data base of automatic qualifiers. Additionally, those people who submitted an entry outside the automatic qualification process are also entered into the data base. Although we cannot publish the list of all those who qualify, if a workplace campaign requests a list of qualifiers from their own company, United Way of Southwestern Indiana can provide it prior to the drawing, but after all pledges received by December 31, 2017 have been posted.
