

## **2019 United Way SWI Campaign Donor Incentive Cash Giveaway**

This incentive promotion conducted by the United Way of Southwestern Indiana (UWSWI) begins at 8 a.m. Central Standard Time on August 1, 2019, and ends at 5 p.m. Central Standard Time on December 31, 2019. Any pledge or gift to the 2019 UWSWI Campaign that was received prior to August 1, 2019 will be eligible. Participants must be legal residents of Vanderburgh, Warrick or Spencer Counties in Indiana; or be employed by a company /organization located in Vanderburgh, Warrick or Spencer Counties in Indiana. Participants must be at least 18 years of age and possess a United States government-issued identification.

The grand prize winner will receive a check in the amount of \$10,000 from Heritage Federal Credit Union. No campaign contributions were used for this prize. Odds of winning depend on number of eligible entries received.

Any UWSWI individual donor that timely increases his/her gift by at least \$50 over his/her 2018 Campaign Gift will be automatically entered for one chance to win. Any UWSWI individual donor that timely increases his/her gift by at least \$100 over his/her 2018 Campaign Gift will be automatically entered for two chances to win. Any new donor that pledges a Campaign Gift of \$50 or more will be automatically entered for one chance to win. Any new donor that pledges a Campaign Gift of \$100 or more will be automatically entered for two chances to win. Entry without donation can also be made by completing an Official Entry Form, which can be picked up at the United Way Office located at 318 Main Street, Suite 504, Evansville, IN. Only one non-donation entry, per person, is allowed.

Pledges or Entry Forms must be returned to the UWSWI by 5 p.m. Central Standard Time on December 31, 2019. UWSWI will not be responsible for companies that fail to submit their employees' pledge forms or employees' names by this date. UWSWI will not be responsible for lost or misdirected mail. All late, lost or incomplete entries are invalid entries, regardless of cause.

Three finalists will be randomly drawn by January 31, 2020. The final drawing of the winner of the grand prize will take place at Heritage Federal Credit Union in February 2020. Finalists must be present to win. Finalists will be notified by telephone and/or email. They will have 5 days to respond to the notification. If any finalist fails to respond within the given time period, an alternate finalist will be chosen. Employees, officers and directors of UWSWI or Heritage Federal Credit Union (or members of their immediate families) are not eligible to participate.

The winner is required to provide proper photo identification and verification of compliance with these rules upon presentation of the prize.

By entering, all participants hereby agree to comply with these Rules, represent that he/she is eligible, consents to the use of his/her name and/or photograph for publicity purposes without further

compensation, unless prohibited by law. All entrants release UWSWI, Heritage Federal Credit Union and their employees, directors, officers and agents, parent, subsidiary and affiliated companies, advertising, fulfillment, publicity and promotion agencies from any and all claims or liability in connection with their participation in this promotion. **Ensuring the Integrity of the Cash Prize Drawing Entries:**

Those individuals that qualify for the cash prize are automatically and systematically (not manually) entered into the drawing as their pledges are processed. Participating workplace campaigns that provide individual donor information to the United Way can be assured that their donations will be eligible for the drawing. Companies that do not typically provide individual pledge information may submit a list of those employees who have qualified. Those names are added to the data base of automatic qualifiers. Additionally, those people who submitted an entry outside the automatic qualification process are also entered into the data base. Although we cannot publish the list of all those who qualify, if a workplace campaign requests a list of qualifiers from their own company, United Way of Southwestern Indiana can provide it prior to the drawing, but after all pledges received by December 31, 2019 have been posted.
