2020 United Way SWI Campaign Donor Incentive Cash Giveaway



Sponsorship

The 2020 United Way SWI Campaign Donor Incentive Cash Giveaway is sponsored by Heritage Federal Credit Union in conjunction with United Way of Southwestern Indiana, Inc. **No campaign contributions were used for this prize.**

Entry Period

This incentive promotion conducted by the United Way of Southwestern Indiana (UWSWI) begins at 8 a.m. Central Standard Time on September 1, 2020, and ends at 5 p.m. Central Standard Time on December 31, 2020. Any pledge or gift to the 2020 UWSWI Campaign that was received prior to September 1, 2020 will be eligible.

Pledges or Entry Forms must be returned to the UWSWI by 5 p.m. Central Standard Time on December 31, 2020 to be eligible. UWSWI will not be responsible for companies that fail to submit their employees' pledge forms or employees' names by the deadline. UWSWI will not be responsible for lost or misdirected mail. All late, lost or incomplete entries are invalid entries, regardless of cause.

Eligibility

Participants must be legal residents of Vanderburgh, Warrick or Spencer Counties in Indiana; or be employed by a company /organization located in Vanderburgh, Warrick or Spencer Counties in Indiana. Participants must be at least 18 years of age and possess a United States government-issued identification. Employees, officers and directors of UWSWI or Heritage Federal Credit Union (or members of their immediate families) are not eligible to participate.

Prize and Odds of Winning

The grand prize winner will receive a check from United Way of Southwest Indiana, net of applicable state and federal taxes. Odds of winning depend on number of eligible entries received.

How To Enter

- Any UWSWI individual donor who maintains his/her 2019 Campaign pledge amount (minimum \$50) will be automatically entered for one chance to win.
- Any UWSWI individual donor who increases his/her pledge by at least \$50 over his/her 2019 Campaign pledge amount will be automatically entered for two chances to win.
- Any UWSWI individual donor who increases his/her pledge by at least \$100 over his/her 2019 Campaign pledge amount will be automatically entered for three chances to win.
- Any new UWSWI donor that pledges a Campaign gift of \$50 or more will be automatically entered for one chance to win.
- Any new UWSWI donor that pledges a Campaign gift of \$100 or more will be automatically entered for two chances to win.

Entry without donation can also be made by completing an Official Entry Form, which can be picked up at the United Way Office located at 318 Main Street, Suite 504, Evansville, IN. Only one non-donation entry, per person, is allowed.

Selection and Notification

Three finalists will be randomly drawn by January 31, 2021. Finalists will be notified by telephone and/or email. They will have 5 days to respond to the notification. If any finalist fails to respond within the given time period, an alternate finalist will be chosen. The final drawing of the winner of the grand prize will take place at Heritage Federal Credit Union in February 2021. Finalists must be present to win.

Agreement to Rules and Rights Granted

By entering, all participants hereby agree to comply with these Rules, represent that he/she is eligible, consents to the use of his/her name and/or image for publicity purposes without further compensation, unless prohibited by law.

Integrity of Cash Prize Drawing Entries

Individuals who qualify for the cash prize are automatically entered into the drawing as their pledges are processed. Participating workplace campaigns that provide individual donor information to the United Way can be assured that their donations will be eligible for the drawing. Companies that do not typically provide individual pledge information may submit a list of those employees who have qualified. Those names are added to the database of automatic qualifiers. Additionally, individuals who submit an entry outside the automatic qualification process are also entered into the database. Although we cannot publish the list of all who qualify, if a workplace campaign requests a list of qualifiers from their own company, United Way of Southwestern Indiana can provide it prior to the drawing, but after all pledges received by December 31, 2020 have been posted.
