TAX BENEFITS

The tax deduction created by the 2020 CARES Act has been **extended** for the 2021 tax year. Tax filers who claim the standard deduction are eligible to deduct up to \$300 in charitable contributions made in 2021. In addition, joint filers can now claim a deduction worth up to \$600. *Payroll deductions made in 2022 will not be eligible unless it is extended again.

"FAIR SHARE" GIVING

Individuals who donate either one hour of pay per month or 1% of their annual salary are considered "fair share" givers. Your workplace may have it's own definition of "fair share." Check with your campaign chairperson to see if your company offers incentives for fair share giving.

Even modest deductions from each pay period or recurring monthly gifts add up to make a big difference!
