We connect people to people, needs to resources, and commitments to action.

### ● EMPOWERING EMPLOYMENT

- 17 neighborhood career placement sites established
- 16 scholarships awarded to low-income students for CDL training and licensure
- Transportation for more than 400 low-income riders

### ● KINDERGARTEN READINESS CAMP

- 95% of KCamp students demonstrated improvement in pre-literacy skills

### ● VOLUNTEER INCOME TAX ASSISTANCE

- 809 returns filed for limited-income clients, with more than \$850,000 in returns

### ● MENTAL HEALTH CARE

- 90% of individual/family clients maintained or improved their mental wellness
- 82% of students maintained or improved their mental wellness
